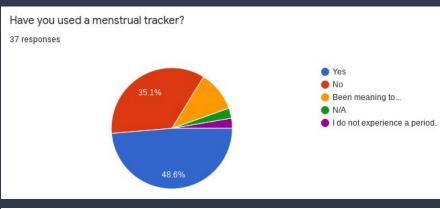
What?

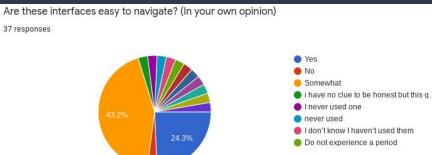
Apps and resources that are catered to menstrual health have been generalized to fit the target audience of adult women, as well as, not to the individual consumer.

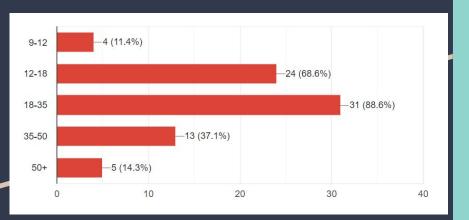

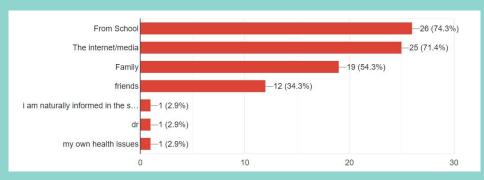

 We found information about existing products by searching the app store for reproductive health apps and by reading articles about apps.

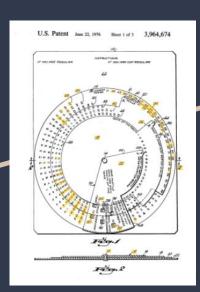
What we learned:

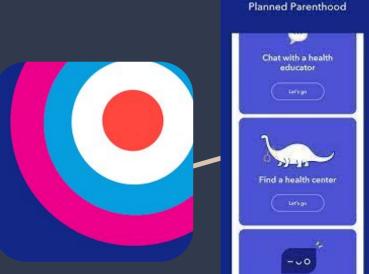

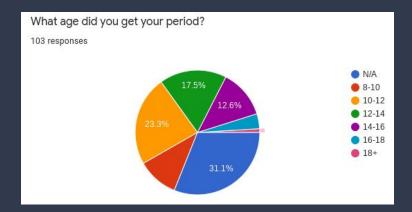

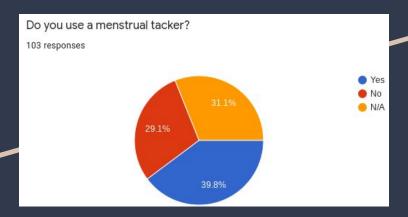
Pros:

- Alert the consumer what time to take their birthcontrol to better create a habit of remembering to take their medication.

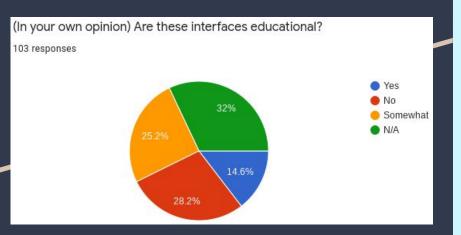




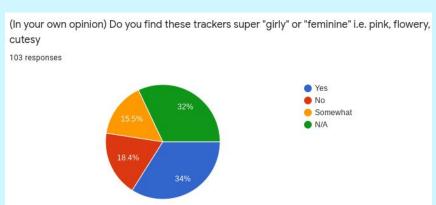
Our primary stakeholders are people who experience menstrual cycles but more specifically, pre-teens and teens who have just started to experience their menstrual cycles.

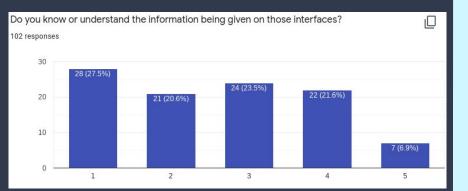
We sent out of survey to collect information through some guided questions and a free response section where people could put in any of their own concerns about these interfaces
